

Term & Condition for Applying as Faculty of Masterclass University Program

1. I agree to participate as a Guest Speaker / Resource Faculty / Chairperson at the Masterclass University Program – after being invited for the same by the scientific coordinators of Masterclass.
2. I acknowledge that this is going to be an online program – limited to teachers of Orthodontics (Orthodontist only) and post-graduate students in Orthodontics of institutes that ECO Academy has signed an MOU (Memorandum of Understanding) with only.
3. I agree to present my lecture in the online program on the "Date and Time" that will be communicated to me by the scientific coordinators after mutual discussion with me.
4. I agree to comply with all program-related deadlines provided to me by the scientific coordinators.
5. I agree to provide my brief biodata and photograph for printing in Masterclass Symposium / University Program proceedings, posting on the masterclass website and other social media handles.
6. I understand that my presentation is educational in nature, matches the session description, and the scientific coordinators reserve the right to change the duration and schedule of the presentation with prior information.
7. I agree that my presentation shall be without any commercial interest in the products discussed. In case of any violation, I shall be subjected to legal proceedings whichever may be deemed suitable by partners of ECO Academy.

I agree to notify the scientific coordinators of Masterclass University Program immediately if an emergency should restrain me from meeting my obligation as a Speaker / Resource Person / Chairperson and will make every attempt possible to provide a qualified substitute Speaker/ Resource Person / Chairperson.
